

Limited Manufacturer's Warranty

1. This Limited Warranty (the "Warranty") applies to all Magnation Products (the "Product" or "Products") originally purchased from Magnation Water Technologies or its authorized dealers and resellers exclusive of personal-use products ("Personal Products"): Powerband™, Hydrabolt™, Springbolt™ and SoftRain™.

Magnation Water Technologies will repair or replace Products when there is a defect in materials or workmanship within seven (7) years for stainless steel products, and one (1) year for anodized aluminum and PVC/plastic products from the date of shipment to the original purchaser (the "Purchaser").

Hydrabolt™, Springbolt™ and Soft Rain™ have one (1) year warranties from date of shipment.

Powerband™ has a 30 day warranty from date of shipment.

2. This warranty covers repair or replacement of the Product(s) at the discretion of Magnation Water Technologies, and does not cover installation or removal of the Product(s), shipping costs to Magnation Water Technologies, or damage to equipment or property adjacent to the Product(s), nor does it pertain to Product(s)'s performance.
3. Magnation Water Technologies shall in no event be responsible for incidental, consequential or punitive damages arising out of or in any manner connected with the installation, use and/or removal of the Product(s). If Magnation Water Technologies is found liable under any other theory, its liability shall in no event exceed the cost amount paid by the Purchaser for the Product(s).
4. When returned pursuant to this Warranty, the Product(s) must be properly crated and shipped by the Purchaser to Magnation Water Technologies, following receipt of a written or emailed return authorization which may be obtained by contacting Magnation Water Technologies Warranty Department. Magnation Water Technologies will repair or replace defective returned Product(s) that fall within the coverage of this Warranty and ship them to Purchaser at Magnation's expense. If returned Product(s) are determined to be not defective, to be tempered with, or otherwise not covered by this Warranty, Magnation will ship Product(s) to Purchaser at Purchase's expense.
5. This Warranty is void under the following circumstances:
 - (1) The Product was purchased new or used from any source other than Magnation Water Technologies or its authorized dealers and resellers;
 - (2) The Product is no longer owned by or in the possession of its Purchaser;
 - (3) The Product was not properly installed.
 - (4) Customer agrees not to tamper with the equipment under any circumstances.
6. This Warranty is the exclusive warranty in lieu of all other express and implied warranties including the implied warranties for merchantability and fitness for a particular purpose. This Warranty may not be amended except by a written agreement signed by the President of Magnation Water Technologies.
7. The exclusive venue for all legal actions brought pursuant to this Warranty or any matter pertaining to the Product(s) shall be conducted in the Superior Court of California, County of Alameda, and California law shall exclusively apply to this Warranty and all matters pertaining to the Product(s).

Two Year Satisfaction or Your Money Back Guarantee

Magnation Water Technologies offers a satisfaction guarantee for all inline units, within two years from date of shipment. Personal use Hydrabolt™, Springbolt™, Soft Rain™ and Powerband™ do not apply. If no benefits are realized by the end of the two year period, a full refund for the purchase amount will be issued once the product is returned in good condition, ordinary wear and tear excepted. The customer must properly package the unit and pay for shipping with tracking to 660 4th Street, Oakland, CA 94607. Proper insurance is recommended.
